Step 1:

Visit www.usmfcu.org

Step 2:

Online Banking will always be on the main page.

Click “Enroll Now”



Step 3:

You will be transferred to our Net Branch domain for an enrollment application.



Step 4:

After you are done filling out the form, you will see this:




Your Login ID is your Member Number

Step 5:


In a separate tab, open your email account.

The email that you provided in the application, is the one that you will use to confirm your identity.




Open the email and click the link provided to validate your enrollment and obtain your password.

You must confirm your identity, please enter your Member Number and the last 4 digits of your social security. The same information you provided for the "Enrollment Application".



Step 6:

After you put in the requested information, you will receive a temporary password:




Copy the password, make sure you copy it somewhere else in case you lose it.

Step 7:


You are then prompted to log in to online banking.

Please follow the guidelines for the new password.


****** We suggest you don't use the same password as for social networks. Choose a new password, one that can be secured.



- **Please choose your security questions**, these will be used in the case that you are unable to login to your online banking account.
- You can “register your PC”, meaning that you will not be asked security questions every time that you use online banking on your personal or frequent computer.
- Once you enter all your information, make sure that you do not share your answers, since hackers can easily use that information to figure out your passwords.

When you are done entering all your information, Click “Continue”.

Electronic funds transfers (“EFTs”) are electronically initiated transactions through Online and Mobile Banking transactions involving your deposit accounts.
